1	<6,000 to 15,000	10,000	200	10
2	15,0001 to 25,000	20,000	300	40
3	25,001 to 50,000	30,000	500	50
4	50,001 to 1,00,000	40,000	1000	60
5	Above 1,00,000	50,000	2000	100
