

4	Approval for using NIC software for billing and collecting of water and sewerage charges.	Elaborately discussed on billing system and requested to pursue the matter with the NIC and IT Department.
5	Approval for conducting door to door survey on household connection of water Supply in Agartala city.	It was decided to conduct and complete door to door survey on household connection of water Supply in Agartala city within short period.
6	Hiring of Vehicle for the officials of Jal Board	It was decided to hire 1(one) vehicle model M&M Balero for using of the Executive Engineer (DDO) of Head Office of the Jal Board.
7	Purchase of Computer, printer, photo copy Machine and installation of AC machine for Head office of TJB.	The Board has approved the proposal for purchasing few Computers, Printer, Photo copy Machine etc and installation of few AC Machine for smooth functioning of office work. Total estimated cost is Rs. 11.89 Lakh.
8	Appointment of different categories of staff for Head office of The Jal Board.	It has been requested the Municipal Commissioner of AMC to depute 2 nos Group D staff for Head office of Tripura Jal Board. It was also decided to process a proposal to Finance Department to depute 1(One) Accountant and 2 nos Data Entry Operator cum Office Assistant for Head office of Jal Board.
9	Issuing of licence to the Plumber	There is provision in the Tripura water and Sewer (Tariff and Metering) Regulations 2021 that every plumber should have licence to work under/ jurisdiction of Jal Board. Accordingly, the Board has decided to issue licence to the plumbers those who are interested to do works within the jurisdiction of Jal Board after giving proper training to them with the help of SIPARD. It was also decided only licence holder plumbers can do the works of drinking water supply lines and sewerage line within the jurisdiction of Jal Board.
10	Engagement of Meter reader for taking Meter reading and delivering the bill to the consumer.	Elaborate discussion held on the issue. Thereafter, the board has decided to engage local Woman Self Help Group (SHG) for taking Meter reading and collecting water & sewerage charges from the consumer by giving money receipt to them. It was also decided to give proper training to Woman Self Help Group (SHG) on taking Meter reading and collecting of water & sewerage charges from the consumer. It was also decided to find out the online based

11	Approval for collection of water charge as per revised rate notified by UDD on 19.09.2019.	<p>At present, AMC is collecting water charges @Rs.40.00/month per household connection though there was a decision to collect the water charges as per revised rate notified by UDD on 19.09.2019.</p> <p>In the Board meeting, elaborate discussion was held on this issue about to meet up O&M cost of water supply and sewerage schemes.</p> <p>Thereafter, the Board has decided to collect the water charges as per revised rate notified by UDD on 19.09.2019 with effect from 1st April, 2022.</p> <p>At present no sewerage charge is taken from the consumer.</p> <p>In the board meeting, it was also decided sewerage charge will also be taken from the consumer from 1st April, 2022 as per following rate. i.e</p> <p>Sewerage charge will be 40 % of water charge for all category of consumer.</p>
12	<p>Appraisal on liabilities of DWS Division-I which has come under TJB and needed decision on liabilities.</p> <p>Liabilities in DWS Division-I</p> <p>1.
