Subject: - Enhancement of water charges & penalty for regularization of unauthorized individual domestic connection.


As per the proposal of Tripura Jal Board and with the approval of the 5th Board Meeting of Tripura Jal Board held on 07/05/2025 under the chairmanship of Hon'ble Chief Minister, Tripura (Chairman of Tripura Jal Board), the proposal for enhancement of water charges & penalty for regularization of unauthorized domestic connection was incorporated in the minutes of the meeting circulated vide file No.- F.5(2)/CEO/TJB/2021/8013-23 Dated- 3rd June 2025 are as follows:

Sl No	Description of Item	Existing Provision / Rate	Revised provision/ Rate w.e.f. 01.06.2025
1	Water charges for an individual domestic connection in Urban Areas (AMC & Municipal Council & Nagar Panchayet area)	₹ 40.00 /- Per Month	₹ 60.00 /- Per Month
2	Water charges for Commercial Connection.	₹ 300.00 /- Per Month	₹ 300.00 /- Per Month
3	Charges for the regularization of existing unauthorized connections.	₹ 1000.00 /- Per Connection	₹ 1500.00 /- Per Connection

N.B.- All commercial water connections should be meter-based. Any connection other than domestic households will be treated as a commercial connection and the records are to be cross-checked with the AMC registration.

All concerned PWD (DWS), Municipal Commissioner AMC, Chief Executive Officer Municipal Council, Executive Officer, Nagar Panchayat, take necessary action accordingly.

The revised rate has been effective since 01.06.2025
